## **INFORMATION WE MAY COLLECT FROM YOU**

We may collect and process the following data about you:

• Information you give us. You may give us information about you by filling in forms on our site www.matalan.jobs (our site), uploading information to our site, or by corresponding with us by phone, e-mail or otherwise. This includes information you provide when you register to use our site, search for job vacancies, participate in discussion boards or other social media functions on our site and when you report a problem with our site. The information you give us may include your name, address, e-mail address and phone number, education and employment history, personal description and photograph.

If you do not choose to do so, you will not be able to view or modify this information. - **Information we collect about you.** With regard to each of your visits to our site we may automatically collect the following information:

We may disclose your personal information to third parties:

  which case personal data held by it about its customers / website account holders will be
  one of the transferred assets.

#### WHERE WE STORE YOUR PERSONAL DATA
